### North Canton City Council Ordinance, Rules and Claims Committee

#### Ordinance No. - 2018

An ordinance repealing and replacing ordinances 105-78, 3581-75, and 3544-75, prohibiting, at all times, right turns or red at certain intersections regulated by traffic control signals, and prohibiting right turns on red between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday, at certain intersections regulated by traffic control signals, and declaring the same to be an emergency.

WHEREAS, the City of North Canton wishes to prevent or reduce the likelihood of motor vehicle accidents at certain intersections controlled by traffic control signals, specifically, those involving inadequate sight distances or pedestrian conflicts with right-turn-on-red maneuvers, and most especially those intersections utilized often by children, older pedestrians, or persons with disabilities.

WHEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO, that ordinances 105-78, 3581-75, and 3544-75, prohibiting, at all times, right turns on red at certain intersections regulated by traffic control signals, and prohibiting right turns on red between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday, at certain intersections regulated by traffic control signals, are hereby repealed and replaced with the following:

- Section 1. That pursuant to Section 4511.13 of the Ohio Revised Code, right turns on a red signal are prohibited, at all times, at the following intersections regulated by traffic control signals:
  - A. South Main Street and Everhard Road SW, south-bound turns only;
  - B. Portage Street NW and Pittsburgh Avenue NW, west-bound turns only;
  - C. City Square, i.e., North Main Street, South Main Street, East Maple Street, and West Maple Street, all right turns on a red signal;
  - D. North Main Street and 7th Street NE, east-bound turns only;
  - E. South Main Street and Schneider Street NE; east-bound turns only.

Section 2.	That pursuant to Section 4511.13 of the Ohio Revised Code, right turns
	on a red signal are prohibited between the hours of 8:00 a.m. and 4:00
	p.m., Monday through Friday, at the following intersections regulated by
	traffic control signals:

- A. North Main Street and Charlotte Street NE, north and south-bound turns only;
- B. East Maple Street and Clearmount Avenue NE, all right turns on a red signal;
- C. Hillcrest-Avenue NW and West Maple Street, all right turns on a red signal;
- bound turns only.
- Section 2. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.
- Section 3. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and peace of the City of North Canton and further necessary to prevent or reduce the likelihood of motor vehicle accidents at certain intersections controlled by traffic control signals, specifically, those involving inadequate sight distances or pedestrian conflicts with right-turn-on-red maneuvers, and most especially those intersections utilized often by children, older pedestrians, or persons with disabilities; provided it receives the affirmative vote of six or more members of Council elected thereto, this ordinance shall take effect and be in force from and after the earliest period allowed by law.

#### North Canton City Council Ordinances, Rules & Claims Ord. No. - 2018

An ordinance prohibiting medical marijuana cultivators, processors, and retail dispensaries licensed under Ohio Revised Code Chapter 3796, Medical Marijuana Control Program, within the City of North Canton, and declaring the same to be an emergency.

WHEREAS, Ohio's General Assembly adopted and its Governor signed into law House Bill 523, codified in Chapter 3796 of the Ohio Revised Code; and

WHEREAS, Ohio Revised Code Chapter 3796, among other things, permits licensed physicians to recommend the use of medical marijuana to patients within the State of Ohio, and creates State regulatory oversight of the cultivation, processing, and sale of medical marijuana; and

WHEREAS, Ohio Revised Code Section 3796.29 authorizes the legislative authority of a municipal corporation to adopt by ordinance restrictions including the prohibition of cultivators, processors, and retail dispensaries within said municipal corporation; and

WHEREAS, the City of North Canton, as with other municipal corporations and boards of township trustees, takes legislative notice that the use, possession, cultivation, distribution, and sale of marijuana, whether for medical or recreational use, remains illegal under the Controlled Substances Act, codified at 21 U.S.C. Section 841; and

WHEREAS, pursuant to the Controlled Substances Act, North Canton has enacted and codified Chapter 531, Drug Abuse Control, therein banning the cultivation, processing, and sale of marijuana; and

WHEREAS, this Council has determined that in the best interest of the City's health, welfare, and safety to prohibit the cultivation, processing, and dispensing of marijuana for medical purposes with the City pursuant to Ohio Revised Code Section 3796.29.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

- Section 1. That cultivation, processing, and retail dispensing of marijuana for medical purposes, as defined in Chapter 3796 of the Ohio Revised Code, is hereby specifically prohibited with the City of North Canton.
- Section 2. That for the purpose of this ordinance, "medical marijuana" shall have the same meaning as defined in Section 3796.01(A)(2) of the Ohio Revised Code.

- Section 3. That a new section of Chapter 513, Drug Abuse Control, is hereby created and titled "513.15 Medical Marijuana," which shall restate Sections one and two above.
- Section 4. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.
- Section 5. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and peace of the City of North Canton, and further necessary to protect our children, families, workforce—our City—from the increased exposure of marijuana, and the consequences thereof, that may result from legalizing marijuana for medical use; wherefore, provided it receives the affirmative vote of six or more members of Council elected thereto, this ordinance shall take effect and be members of Council elected thereto, this ordinance shall take effect and be in force from and after the earliest period allowed by law.

### North Canton City Council Ordinance, Rules and Claims Committee

#### Ordinance No. - 2018

An ordinance amending Chapter 505, Animals and Fowl, specifically adding Section 505.19 Management of Cat Population: Permitted Act, to the Codified Ordinances of the City of North Canton.

WHEREAS, the City of North Canton wishes to protect public health and safety by managing animal control issues such as nuisance animals and animals running at large; and

WHEREAS, sterilization and vaccination programs, such as Trap-Neuter-Return ("TNR"), offer a humane and proven way to resolve conflicts, reduce population, and prevent disease outbreaks by including vaccination against rabies and other potential diseases; and

WHEREAS, TNR programs are embraced by hundreds of local governments and are becoming the primary method of feral cat management.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

- Section 1. That Chapter 505 Animals and Fowl is hereby amended, specifically to add Section 505.19 Management of Cat Population: Permitted Act.
- Section 2. That Section 505.19 Management of Cat Population: Permitted Act, shall read as follows:

#### 505.19 MANAGEMENT OF CAT POPULATION: PERMITTED ACT.

- (a) <u>Definitions.</u> For purposes of this Section, the following terms shall have the following meanings:
- (1) "Community Cat" shall mean a cat that is abandoned, stray, lost, or feral within the City of North Canton, which may be cared for by a Community Cat Caregiver, known or unknown, pursuant to this ordinance.
- (2) "Community Cat Caregiver" shall mean a person who, in accordance with and pursuant to a policy of Trap-Neuter-Return ("TNR"), provides or obtains medical care and other appropriate care for Community Cats, while not being considered the owner, harborer, controller, or keeper of Community Cats.

- (3) "Eartipping," which is used to identify Community Cats as being sterilized and lawfully vaccinated for rabies, shall mean the removal of approximately ¼ of an inch off the tip of a Community Cat's left ear, in a straight line, while the cat is anesthetized, and in compliance with any applicable federal or state law, and under the supervision of a licensed veterinarian.
- (4) "T-N-R" shall mean the process of humanely trapping, evaluating, sterilizing, vaccinating for rabies, eartipping, and returning Community Cats to their original location.
- (b) Permitted Act. The following action shall be permitted in the City of North Canton in pursuance of a policy T-N-R:

Trapping Community Cats for the sole purpose of sterilizing, vaccinating for rabies, and earlipping in compliance with this T-N-R- policy, together with any applicable federal or state law, and under the supervision of a licensed veterinarian, where applicable.

- Section 3. That Community Cat Caregivers, for the clear purpose of the furtherance purpose of this ordinance, are exempt from applicable provisions of North Canton and the Adminiscretified ordinance 505.01 Dogs and other Animals Running at Large.
- Section 4. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.
- Section 5. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.

WHEREAS, Ohio's General Assembly adopted and its Governor signed into law House Bill 523, codified in Chapter 3796 of the Ohio Revised Code; and

WHEREAS, the federal government regulates drugs through the Controlled Substances Act, which classifies marijuana as a Schedule 1 drug with no currently accepted medical use, together with a high potential for abuse. 21 U.S.C. 812.

WHEREAS, pursuant to the Controlled Substances Act, North Canton has enacted and codified Chapter 531, Drug Abuse Control, therein banning the cultivation, processing, and sale of marijuana; and

WHEREAS, this Council has determined in the best interest of the City's health, welfare, and safety that it shall neither permit nor accommodate a City employee's use, possession, or distribution of medical marijuana. Ohio Revised Code Section 3796.08. A copy of the amended Drug Testing Policy is attached hereto and included herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

- Section 1. That the federal government regulates drugs through the Controlled Substances Act, which classifies marijuana as a Schedule 1 drug with no currently accepted medical use, together with a high potential for abuse. 21 U.S.C. 812.
- Section 2. That pursuant to the Controlled Substances Act, North Canton has enacted and codified Chapter 531, Drug Abuse Control, therein banning the cultivation, processing, and sale of marijuana.
- Section 3. That this Council has determined in the best interest of the City's health, welfare, and safety that it shall neither permit nor accommodate a City employee's use, possession, or distribution of medical marijuana. Ohio Revised Code Section 3796.08.
- Section 4. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.

Section 5. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and peace of the City of North Canton, and further necessary to protect our guests, residents, and workforce—the City itself—from the consequences relating to a City employee's use, possession, and distribution of marijuana, be it for medical purposes or otherwise; wherefore, provided it receives the affirmative vote of six or more members of Council elected thereto, this ordinance shall take effect and be in full force immediately upon its adoption by Council and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

#### DRUG TESTING POLICY

- Drug screening or testing shall be conducted upon reasonable suspicion. This testing shall be solely for administration purposes and the results obtained shall not be used in any criminal proceeding. Under no circumstances may the results of the drug screening or testing be released to a third party for the use in a criminal prosecution against the affected employee. The following procedures shall not preclude the employer from other administrative action.
- Drug testing shall also be authorized when an employee is involved in an on-duty motor vehicle accident which results in bodily injuries to any vehicle occupants or the employee, or when the employee has discharged a weapon while on duty.
- All drug screening tests shall be conducted by medical laboratories licensed by the State
  of Ohio and accredited by the College of American Pathologists or other mutually agreed
  upon entity. The procedures utilized by the testing lab shall correspond to accepted
  medical practice. Any positive result shall be confirmed by a mass spectrophotometry
  procedure (GS-MS), or any approved subsequent state-of-the-art confirmatory test.
- Drug screening tests shall be given to employees to detect the illegal use of controlled substances as defined in Section 3719 of the Ohio Revised Code. If the initial screening is positive, the employee's sample shall be subjected to a confirmatory test that shall be administered by a medical laboratory licensed by the State of Ohio and accredited by the College of American Pathologists or other mutually agreed upon entity. The employee may have a second confirmatory test of the split sample done at a lab of his choosing, at this expense. This test shall be given the same evidentiary weight as the previous test, provided a neutral chain of custody remains unbroken.
- If all the screening and confirmatory tests are positive, then the Bargaining Unit Member involved may be required to enter into rehabilitation referral. The City shall maintain the right to discipline the employee in addition to mandating rehabilitation.
- Prior to any notification by the Employer for drug screening or testing, an employee may
  elect to participate in a rehabilitation or detoxification program, as determined by
  appropriate medical personnel. The cost of the program will be covered according to the
  provisions of the employee's health insurance plan.
- An employee who participates in a rehabilitation or detoxification program shall be allowed
  to use sick leave, vacation leave, or personal days for the period of the rehabilitation. If
  no such leave credit is available, such employees shall be placed on leave of absence
  without pay for the period of the rehabilitation leave.
- Upon completion of the program, and provided that a retest demonstrates that the employee is no longer illegally using a controlled substance, and/or subject to any disciplinary action that may be taken pursuant to this Article, the employee shall be returned to his position. Such employee may be subject to random retesting upon return to his position for a period of one year from the date of his return.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

- Section 1. That the Director of Administration of the City of North Canton, be, and is hereby authorized to advertise and receive bids according to specifications now on file in the Director's office for the resurfacing, repaving, replacement, repair, and preventative maintenance of certain City streets, alleys, and parking lots.
- Section 2. That the Mayor of the City of North Canton, upon Board of Control approval, be, and is hereby authorized to enter into a contract for the resurfacing, repaving, replacement, repair, and preventative maintenance of certain City streets, alleys, and parking lots, at a cost not to exceed \$852,000.00.
