Ordinance No. 70 - 2018

An ordinance amending Chapter 553, Weeds, Trees and Grass, of the Codified Ordinances of the City of North Canton, specifically, amending Section 553.01, Obstructions on lawn strips and lawn debris in street gutters, by adding subsection (c) as described below.

WHEREAS, the interest of public safety and the upkeep of the City's housing stock require residents to maintain their pavement, driveways, curbs, gutters, sidewalks, and lawn strips to prevent encroachment from adjacent grassed areas and ground cover.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

Section 1. That Chapter 553, Weeds, Trees and Grass, of the Codified Ordinances of the City of North Canton, be, and is hereby amended, specifically, amending Section 553.01, Obstructions on lawn strips and lawn debris in street gutters, by adding subsection (c), as described below:

(c) In the interest of public safety, all pavement, driveways, curbs, gutters, sidewalks, and lawn strips shall be edged when necessary to prevent encroachment from the adjacent grassed areas or ground cover.

Section 2. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that it shall not affect the validity or enforceability of any other provision of this ordinance.

Section 3. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.
