CALL TO ORDER:

1. The organizational meeting was called to order Wednesday, December 1, 2010 at 6:30 p.m. by Mayor David J. Held.

Mr. Revoldt: That concludes our business this evening. May I have a motion to adjourn?


Mr. Foltz moved and Mrs. Kiesling seconded to adjourn the organizational meeting. All members present voting:
