> Mayor Held: Yes, yes I was. Originally what we wanted to do was to consolidate the departments. And so we were striving for a cost savings. And what we did is we eliminated the Assistant Chief position because that person was no longer serving. So we have not added any

Mrs. Kiesling: Right, I know that.

Mayor Held: for this right now. But what we need to do is there is somewhat of a void of leadership when the Chief is out of town. And really what we need is somebody to be assigned as the point person or the acting chief when he is not in the area or unavailable. Right now what we do is we have a series of captains that would be in charge of a particular scene in the event that the Chief is not available. So originally it was done because we had appointed a full time fire chief and eliminated the part-time fire chief position and eliminated the full time EMS chief position and at the same time eliminated or did not fill the assistant chief position. So those individuals actually left. But again now we're not adding individuals we're just going to appoint somebody. We're just - it would be a promotion. And it's just to give an individual which would come out of the captain's group the authority to function in that capacity.

Mr. Wise: If I may, on your places there there is a draft of a job description for assistant fire chief. It does a number of things as well. This gives one point person - most all the fire fighters are part-time. This gives one point person that any of the part-timers can come to before they go to the Chief. In addition it allows, again as the Mayor said, the designated chain of command at the scene if the Chief is not there yet or the Chief is away or out of town or is unable to make a particular fire call. This is again a part-time non-Civil Service position. It is a position for the paid on-call, just like it says at the beginning here. It is not a position where if the Chief is on vacation or is off sick that day this person who in all likelihood will have another full time job most of our captains do, will not be called in to be paid an hourly rate while the Chief is on vacation. This is just for training, emergency, disaster scenes; those types of things that a parttime person would normally come in on. Now that's not to say that there couldn't be situations where the Chief and the Assistant Chief get together, I would assume at a training session of after a fire call to discuss some type of personnel matter to better streamline the chain of command and personnel issues, those types of things. That's the request by the Chief and by myself and if there's any questions we're both here to answer them.

It seems the dry system has been compromised in as much as it - there's a generator on there that doesn't work all the time which causes leaks and there's many holes. The tenant and I don't if we have been notified yet, but the insurance company that insurers the tenant has notified them that they have a window of opportunity to either repair it or they'll no longer bind coverage. Because they were under the - they wrote the coverage with the understanding that they have a fire suppression system in the building. As well as the state building code for a building that size does require that you have an operable suppression system. And I realize people are going to say well why are you replacing. It is our structure we own it. It would be the same as any property that any landlord would own you have to maintain the structural integrity of the building as well as the furnace and air conditionings and the suppression systems if there would be one. So that's the situation. There's money in the budget that we're going to look at this particular time coming up. The two present lessees have verbally agreed in conversation to participate in the cost of it. I know Mr. McFarren and Mr. Zumbar are working on what they can work out. But at this present time time is of the essence so we have to move along accordingly. And that's about it. Any questions ... inaudible...

Mr. Snyder: Mr. President, members of Council, this has been an arduous process. We've gone through several public meetings. We've gone through several committee meetings and Council has taken this apart. We feel we have a working document at this particular time. Even though it does contain an emergency, we would request as a committee that you only give it the first reading and adopt same and allow the public input over the next couple weeks should there be any. The document is on view at the Director of Administration – or Director of Finance and if members of the public would like a copy I'm sure he would provide same. And that's about it.

Mr. DeOrio: Mr. President, Mr. Chairman, if I could just take a minute I want to - since I was unable to be here last week for the discussion, you know, portion of it I don't really have too many or really any questions on it since a lot of this was already done through the committee work. But I think just really the point I wanted to emphasize is and it really just comes from a learning curve of my own I guess that I think that this is the fourth budget that I've looked at and each time that I think I've gone through it looking at the line items; I probably looked at emphasis, you know, less on the personnel side and more on the operations or equipment side. The City has done a very good job in the last four budget cycles of reducing their expenditures on those line items. They've done an - the employees have done an exceptional job of keeping such a high standard with the resources that they're working with. And I guess my conclusion is that I really think that we've taken that as far as it can go. Each time that we've done it it's been, you know, a diminishing return, less and less there. As a result, when we entertain that time later in the year to work on the budget I don't think that we're going to - I think any of the time we would spend trying to do that would really be not a good utilization of our time in discussing ideas. I think you've got one of two ways left available to you. You have to look at restructuring, rethinking how you deliver services and the administration has been working on that. And I think there are a lot more steps along those ways that should be explored and then decided on whether or not that same level of service can be given and any substantial cost savings realized. Absent any substantial cost savings realized the only recourse that you'd have left is to somehow modify the revenue side of the equation and there are several things that could be looked at in that regard. But we're really down to that point where it's time for the, you know, the big decisions are going to have to be made. And anyway I just appreciate you letting me chime in ...inaudible... a week later.

Mr. Snyder: We appreciate that and we – and again you were not here last week and I want to thank you for all your input and all your counsel that you brought to the preparation of this budget. Thank you.

Mayor Held: I would like to thank our members - all our members of City Council that worked on this budget. Because I think that at least in the years that I've served as the Mayor and also as the City Administrator previous to this, this clearly was the toughest budget that we've ever had to put together. And it's pretty clear that our revenue has dropped significantly since last year. And overall we've reduced the work force and this really has been - it's been a group effort or behalf of City Council and also the administration and our department heads, but we've reduced the number of employees by twelve (12%) percent when we first started here three years ago. And we've significantly cut our spending. But at the same I think we've all done a pretty good job of maintaining the service. Our employees went from 116 down to I believe 102 or 101 at this point. And although we're not salting as many streets on the back streets, overall there really hasn't been much of a compromise in the service. So I do want to thank all of our members of Council for their hard work on this and I'm very proud of the work that our employees have done also.

Mr. Wise: Mr. President, if I may, I would like to thank the budget committee. We had a number of budget hearings, one of which got canceled due to snow one morning, but we did have a number of those. I thought those were helpful and productive. One of the budget committee members suggested that we do this next year just as soon as a proposed budget is submitted by the Mayor. I think that is a tremendous idea. And we do that even on an ongoing basis informally, but with budget hearings in the Fall when the Mayor submits a budget. Thank you.

Mr. Revoldt: Okay. Does anyone else have any response? I'd just like to follow up on Pat's comments and I don't want to let them - maybe I'll put a little different emphasis on them. I think it's important that, as we discussed, that we are going to revisit budget or revisit our financial situation in April and July. In the interim and we'll make whatever course corrections we need of begin to look at those in April and July. I think it's important however, that we be reminded tha we have an Auditor of State's recommend -- series of recommendations; amongst those that we look at restructuring the way that we've done some business. I think if we're going to be intellectually honest with the tax payers we need to bring that back to this Council, we need to look at it, determine whether it's feasible or not and if it is not then we will review our revenue options at that point. Those revenue options however don't rest with this Council, they rest with the voters. And I think it's important that we have the ability to reassure them that we have looked at this in a thorough and honest fashion. And we have done as Pat suggested everything that we can do to hold the cost - hold our costs down particularly in this economic climate. So that said anything else we need to add? So we need to get back, I guess I would just say to the administration please get - let's try to schedule some times that we can look at revisit the auditor's report and at least discuss and look at those costs and comparisons for restructuring. Let's get back to it sometime sooner rather than later and we'll go. Mayor Held: Right ... inaudible...

We had Council members that were inquiring about the federal stimulus package and just to give you a quick update where we at I'd like to read an exert from a letter that we received from the Ohio EPA Director Chris Korleski. Recently the State of Ohio launched the Recovery Ohio.gov (www.recovery.ohio..gov) website which will serve as Ohio's interactive headquarters for all information regarding the American Recovery Investment Reinvestment Act or the federal stimulus package. The state is asking you to do this in order to ensure a transparent, consistent process to build one comprehensive statewide data base of all potential projects being submitted for consideration. Once a project is submitted by an entity via the website, it will be entered into Ohio's master database and then forwarded to the appropriate state entity. Given the limited amount of stimulus money available and prioritization likely to be given to the projects we can proceed expeditiously. We recommend that you begin submit your project pre-application as quickly as possible. We've already done that in reference to North Canton's projects. We've actually submitted numerous projects. It is not likely that we're going to get grant money for all those projects. But we're hopeful that we'll at least get some money. And we're doing everything we can right now to work with Congressman Boccieri's Office to help move this process along and as we get more information we will keep you posted.

Mr. Revoldt: We're going to get more money than Akron, right?

Mayor Held: Yes. No, we're doing everything we can to get as much as we can. Hopefully we'll get...

Mr. Snyder: Mr. President, along the lines of the Mayor's comments on the stimulus, I noticed that the County will receive money. The City of Canton has applied for in excess of 400,000 for the two railroad trestles that so gracefully hover over the Zimber. The Zimber has been a problem for as many years as you and I have represented that particular ward - you know that. And it is, it is just a large lion waiting to roar and it will happen should it start to rain in any excess. And I would just like to know if there's someway that with the County sales tax initiative they'll have additional revenue with the stimulus, if you may please entertain a suggestion that we send a letter to the County Commissioners asking them to please address - at least dredge that ditch to give those people some hope of relief should it begin to rain. It's a collaborative agreement of all Plain, Jackson - Jackson is as much a contributor to that ditch as North Canton if not more because the upper end from the airport down contributes to it. And I feel people in that particular area they've just really basically given up on us because we've held numerous meetings, we tried to buy their properties and that didn't work one time and some of them moved away because they've become so disenfranchised with our ability to help them that if we don't at least scream just a little bit - the wheel that squeals the loudest gets the most grease. Maybe we can squeal a little. And hopefully - if you would please guide me or the whole Council on how we may approach that.

Mr. Revoldt: Was it – was part of the plan Jim to – my recollection is that after the study was done they were going to create a number of detention basins, which they have done. The next step was to improve flow beneath the bridges that Jon has referenced. Is that correct?

Mr. Benekos: Partly. They have implemented some of the retention basins – not all that they would of liked to have done. The two bridges that you mentioned, I have seen the final plans from METRO and they are proceeding to improve those two bridges, those railroad bridges. However, those won't be the bottleneck; the bottleneck will be at Everhard Road which is a county bridge there. The railroad bridges won't be opened up fully because they don't want to invest the money there because they said the County Engineer's bridge isn't opened up fully. So...

Mr. Revoldt: Okay, so if we would send a letter to the County Engineer asking him to utilize sales tax money...

Mr. Snyder: Stimulus money.

Mr. Revoldt: or stimulus money and apply it to that project would that...

Mr. Benekos: It would be difficult because the bridge is in good condition and there are other bridges in the county that are in poor condition. So if drainage is the only concern it's going to weight low in their estimation. So its' going to be difficult. We can send a letter but ...inaudible...

Mr. Snyder: So there's two schools of thought Mr. Benekos and I know I've heard from both what's his name – the hydraulics fellow?

Mr. Benekos: Gary Connor

Mr. Snyder: Connor – the people that live on the Zimber are very, very emphatic to the fact they feel if – that have lived there for many years, if it is dredged it will allow it to flow a little more. But there's another theory that if you dredge it it is deeper and more water will come into it and consequently it will flood quicker. However, it has become an attic for the community, every tree that's fallen down between Akron/Canton Airport and Everhard is laying in that Zimber along with every tire that was discarded along Whipple Road. And I mean we don't have the funding to clean that up. That they could possibly do or possibly use, I use the word criminal but that's wrong choice of words, what do they call those people from the court?

Mr. Zumbar: Civic Improvement Program.

Mr. DeOrio: Community service.

Mr. Snyder: Civic improvement people that have had – that have encountered minor offenses that possibly they could get some of those people to - and I'm sure Solid Waste would be very generous in providing receptacles to all that way since it wouldn't go into the landfill.

Mayor Held: Right. We can do ...inaudible...
