So what we want to do is have a provision. We can revisit the rate itself, but we need a legal collection mechanism that will pass a state audit. Doug is that...

Mr. Foltz: Well that's fine. I mean I know some members of Council think this is low. And Superintendent Chufar went over that with our Law Director. Yeah, let's get it in the books and review it, maybe we'll do a cost analysis...

Mr. Revoldt: Got to have it - got to have it on the books.

Mr. Foltz: We'll do a cost analysis from other cities. That's fine. I mean giving him some lead way since he runs the department.

Mr. Revoldt: Okay.

Mr. Foltz: I would think he'd know his time and wages involved, especially when using seasonal help. But obviously yes, if the cost is \$82 and we're charging 40, I understand some of the points that some of the Council members are making here. So with that said, I'd like to get this passed and revisit. Just like the pool rates, we're going to revisit that. We seem to do that every couple years. So...

And there is some distress in the asphalt on the west side on the south bound lane, which distresses me and we'll have to address that in the spring. We had three bid openings foday. One was for Main Street resurfacing from Rose Lane to 7<sup>th</sup> Street; we got excellent prices on that. That came in at about 920,000. We had 120 or 1.2 million through federal and state funds. There was no city funds involved in that. But - so we'll be able to turn some money back to the government, we can't place it somewhere else ...inaudible...

Mr. Benekos: We'll use it as liberally as we can, but they'll be - they'll be watching. Stratavon waterline, bids came in very good on that, came in at 72 bout \$73,000. The budget was \$150,000, the final Engineer's estimate was 139,000. Grassemere, the bids came in good on that also, but it's over budget, it's still under the Engineer's estimate. As I explained previously, when we put these estimates together we throw, you know we look at a lot of projects and we throw general estimates out. When we get the final design done is when we do the final estimate. So it's less than the final estimate, it's more than the budget. And I'll be back next week to see if we can get some additional funding into that account, so that we can go ahead and proceed with that project. And I'll explain that

Mr. Snyder: Question on Main Street.

Mr. Benekos: Yes.

Mr. Snyder: What is the time table? You think that could be begun in the early spring and completed - that the people could enjoy the resurfacing as well as - I mean since the bid has been let, they could begin that sometime in May instead of waiting or because it's federal funds it can't begin

Mr. Benekos: No we can start early it's the OPWC (Ohio Public Works Commission) funds that hinder us, but I believe those funds were allocated last July. Mr. Snyder: Right.

Mr. Benekos: We were ahead.

Mr. Snyder: But it would be nice if it would be completed, and people could enjoy that ...

Mr. Benekos: Right.

Mr. Snyder: for a full season.

Mr. Benekos: We just opened bids today. We haven't talked to the Contractor, but I anticipate there's some curb work to be done, catch basins to be replaced, the concrete and the bricks here at the square need to be replaced, the ADA (American Disability Act) ramps. So they can do that work probably starting late April. Then hopefully late May maybe wait till after school's out to be done. There are provisions in there that it has to be substantially complete before the July 4th race of the YMCA. So I think with the bids we got, with the Contractor we got, we should be able to meet that schedule. And we'll be talking with him here in the near

Mr. Snyder: Who's got the bid?

Mr. Benekos: Wenger, Northstar...

Mrs. Loretto: Supposedly ...inaudible...

Mr. Benekos: So we'll move quickly on our part, there's no reason to delay. There are you know, like I mentioned, there are federal funds involved and there's a lot of red tape that we have to go through before we can give them the final award and we'll be working through that here in the next couple of weeks. That's it.

Mayor Held: I do appreciate the work that Jim did over the past six months serving as both Administrator and as Engineer. We're glad that you're still here. Also, snow plowing, you'll probably have a number of residents that are calling you because their yards have been damaged by the snow plows. And I would ask the Council members as you get residents that call with that concern, they can forward those calls over to the Administration and then we put them on a list. When the weather permits we'll be out there and repairing those areas. And a - but sometimes it'll take a little bit of time because it's a weather permitting issue. And also if there are ever any mailboxes, we usually hear about those right away and we go out and repair those mailboxes right away. We did have flooding today and it was really once again for the most part down in the 4<sup>th</sup> Ward, Lucille, Furbee. We had Price Park that was completely a under the walking track and we do send the Fire Department has four pumps - actually it has six smaller pumps, four of which can only pump storm water. And we go out and try to help the people out on a first come first serve basis as we can. But then the cleanup of course is left to the residents. So we're trying to help them out the best we can, particularly in those areas where the creek just rose above normal levels. And - but once again, you can only pump it out once the water recedes. Otherwise you're pumping it out of the basement and it's just coming right back in because that's what the problem is. Also, we have John Minock who was a Patrolman and Frank Kemp who is also a Patrolman; they are now going to be serving as Sergeants. And that's the newly created position because we have two Lieutenants that have retired - one is Joe Nist and the next one will be Lieutenant Steadman. So we have those two serving as replacements. Then Eric Bowles is going to be serving as the Superintendent of Permits Inspections, Zoning, Planning and Nuisance. We normally refer to it as the Permits Department. Eric has a Certificate in Zoning and also experience in Planning. Eric will continue to serve as the Economic Development Director, but he will also serve as the Interim Director of Permits Inspections, Zoning and Planning. And we're going to take a look at that over the next six months. And - but I'm very confident that Eric will keep the office organized and running. And then Mike Grimes, March 2<sup>nd</sup> which is Wednesday, Wednesday, he'll start as the City Administrator and in his place we will have Mike Wurgler who's a Lieutenant and he'll be serving as the Chief - the Police Chief. That will be on an interim basis until we can issue a test for the Lieutenants that are interested in testing for the Chief's position. And then the top three test scores - Chief, how many test takers do we have do you know at this point?

Mr. Grimes (speaking from the audience): You'll have four.

Mayor Held: Four. And then the top three are then in the pool to be selected by myself for and also Chief Grimes to be the next Chief. And that's a – that's all we have.

Mr. Revoldt: The chicken czar is next. Mr. Bowles.

Mr. Bowles: No report.

Mr. Revoldt: Very good. Clerk.
