Mr. Fox: Thank you, Mr. President. As Council is aware there have been a few complaints from some of those that speak at our Recognition of Visitors' times. Some of the complaints have been that they have not received fair allocation of time in comparison to some other speakers. So, I just want to go over a little refresher of the Rules of Council for those that do attend regularly, and just information for those of you that's the first time that you're here for one of our council Meetings. According to our Rules of Council, Chapter 115, citizens are permitted to speak only during the Recognition of Visitors portion of the meetings following this announcement. For each of the visitors, each speaker is requested to identify themselves by their name, address, and the subject matter that they intend to speak about. Speakers will direct their comments to the Presiding Officer, which is President of Council Snyder, and are limited to a maximum of five minutes or at the discretion of the Presiding Officer, the speaker may continue beyond the limit if their remarks are deemed germane, non-redundant and consistent with the rules of decorum. When a speaker speaks for the first time this evening we'll have a small timer on the corner of the screen so the speaker and each visitor can see the amount of time allocated to each speaker. Once the five minutes are up, we ask simply that you pause, the President will make the determination if the remarks are germane, non-redundant, and consistent with the rules of decorum. If they are, you will be permitted to speak for a reasonable additional period of time. If not, we simply ask that you take your seat and respect the other speakers. Also, the speakers are required to observe all the rules of decorum as prescribed in *Robert's Rules of Order*, meaning that there's no debate, disrespect, or personal attacks. Also for the podium, we have had some complaints as well as far as sound quality. Our Clerk has painstakingly looked and found what we believe is the proper spot for the podium for the best in sound quality and for the speaker to address the Presiding Officer. So we ask that you not move the podium. If you need to raise it up or down for your notes, please ask the Clerk and she'll be glad to assist you with that. Nothing else? Thank you.

Mr. Snyder: Okay. Thank you, sir. Appreciate that. Any questions of the Law Director? Thank you. At this time, the Council will recognize anyone wishing to speak. Please step forward and state your name and address for the record. Seeing none, I'll move to Old Business. Excuse me.

Recognition of Visitors:

8. Mrs. McCallan (speaking from the audience): I will, please.

Mr. Snyder: Yes, ma'am.

Mrs. McCallan: Thank you.

Mr. Snyder: Please step forward, state your name and address for the record.

Mrs. McCallan: Hi. I'm Barbara McCallan. My address is 411 Woodside Avenue NE, North Canton, Ohio. The reason I'm here is - actually the last time I was active in this building, in this room, was back in 1981, I was a mere child. But I worked to get an ordinance changed, and now - and that was about a year and a half it took to get that ordinance changed. But here I am trying to defend the ordinance that I worked on. It's being abused in my neighborhood. Didn't like it, don't understand why it should be accepted. And like I said it's been going on like a year that there's nothing being done. I've tried to work with Mr. Bowles. I believe he must be overworked and under paid because it's taken a long time to get this done. I've also asked about, I believe it's called easements and the width of those easements on property that have been, I don't know, granted to furnish another homeowner access to a sewer line from one street, which is specifically Woodside Avenue NE, to Wise, which is Wise NE also, and it goes all the way through private property. Since then the house that was at 423 Woodside has been razed. There is a garage there, along with the driveway, that and has been added to since the house was razed to allow to park a boat and things on this property. I understand under the ordinance concerning this, that in two years if there's not a house built, then this structure must be taken down. Well this is exactly the property that this easement runs through. And it's questionable whether in fact if it would be a buildable lot with this easement access on this property. And I've really asked, what's the width? And I haven't been able to get an answer. I've had some other problems, but if we could - someone could address these or somehow, like I said, an Act of Congress, but in this case an Act of Council to help me out on this, I'd greatly appreciate it. Thanks so much for your time.

Mr. Snyder: Mrs. McCallan, help us understand your request. You, the property, the lot is vacant. Is that correct? It does have a secondary structure, or garage, but, not a primary structure?

Mrs. McCallan: Yes sir, that's right.

Mr. Snyder: Correct. That cannot exist after twenty-four (24) months. The problem that you want to know is that a buildable lot. Is that what you're asking?

Mrs. McCallan: Right. Eric Bowles told me that under the ordinance, they had two years, twenty-four (24) months...

Mr. Snyder: That's right.

Mrs. McCallan: or they had to build a home on this property.

Mr. Snyder: That's right.

Mrs. McCallan: And, at that time they could keep this garage. I don't think they are going to build a house on it; I don't think they are able to with this easement running through it. And to be honest with you the garage has been a form on contention because the water running off of it has damaged our fence and stuff, thus this whole thing began. And we did have to move our fence and repair our fence because of this water runoff. The owner of said property has made very little attempts to solve it. His son does have a piece of equipment that's quite capable of digging out a ditch and taking out to Wise, which is probably about forty-five (45') feet that he could do that would solve our problems. And I wouldn't care how long he took up the garage. He said it blocks the stadium view, if you get my meaning. But anyhow, that is the gist of it. Yes, if that variance is in fact - I think it has to be roughly fifteen (15') feet. Not variance, excuse me, that would be an easement. I think it has to be fifteen (15') foot wide, or at least very close, because I took pictures of a dug up system, and there is a lot, you know, I mean, you have a lot of room. You have working room for the man to go down in the hole. Then you've got storage for the pile of dirt, the excavation. And then you have to have, you know, your pipes to come in and stuff. And I took pictures. And like I said, it's I'd say between ten (10) and twelve (12), or excuse me, ten and fifteen (15') feet allowance. So with a house, or the property being 50.77 feet and our code in that area is fifty (50), it may not be a buildable lot. If so, the garage should come down now; it's not buildable. But that's - I appreciate any help on it. And if you give Eric a little time to, you know, so he can help me out on it. Like I said, it's been - December 11th it's been my first contact with him.

Mr. Cerreta: Barbara, has Eric been out there yet? Do you know if - have you been - have you seen it with Eric out there? Has Eric come out there and looked at it?

Mrs. McCallan: Oh certainly.

Mr. Cerreta: Oh, he has. Okay, we'll talk to him,

Mrs. McCallan: Oh certainly, many times. And I realize he's a busy man. And I realize certain things, but you know, and like I said the home occupation thing, I want something done about it now. North Canton - I'm concerned about how things are sort of - oops, my time - how things are sort of going downhill on all of, you know

Mr. Snyder: Is he -- is he operating a business out of the garage?

Mrs. McCallan: Yes sir. No, not the garage. This is the other property. This is an ordinance property, or ordinance situation at 506.

Mr. Snyder: Oh, this is a different problem.

Mrs. McCallan: Yes. It happens to be the son of the person that owns this property.

Mr. Snyder: He's operating a business out of his home?

Mrs. McCallan: Well yes, essentially, although he owns or rents a business area on North Main for his business. But he is storing vehicles - his employees are coming in there, parking said vehicles, or parking their personal vehicles and taking a company vehicle out, returning it, and this goes on day and night.

Mr. Snyder: Well, I think the thing to do is we'll get a hold of Mr. Bowles in the morning through the Law Department ...

Section 1. To provide for the current expenses and other expenditures of the City of North Canton, Ohio, during the fiscal year ending December 31, 2011, the following funds, be, and are hereby set aside and appropriated as follows:

Section 2. That the Director of Finance of the City of North Canton, be, and is hereby authorized to issue warrants from appropriations established herein for the payment of vouchers duly approved by the proper departmental authority.

Section 3. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.

Section 4. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and peace of the City of North Canton and further necessary to pay for salaries and wages through the end of the year; wherefore, provided it receives the affirmative vote of six (6) or more members of Council elected thereto, this ordinance shall take effect and be in full force immediately upon its adoption by Council and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
