## Resolution No. 61-12

A resolution of submission of question of a renewal of a tax levy for the purpose of providing additional funds for the City's portion of ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio, and declaring the same to be an emergency.

WHEREAS, the City of North Canton upon due investigation and consideration has determined that the amount of taxes which may be raised within the ten (10) mill limitation in and for the City of North Canton, Stark County, Ohio, for the next five (5) years, will be insufficient to provide an adequate amount for the purpose of providing additional funds for the City's portion of ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio, and

WHEREAS, by reason of the facts above set forth, the Council has determined that it should, and hereby does declare itself to submit to the electors of the City of North Canton at the General Election to be held on November 6, 2012 the question of replacing a tax of one and one-half (1.5) mills outside the ten (10) mill limitation for the purpose of providing ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio, for a period not to exceed five (5) years, tax years 2012, 2013, 2014, 2015 and 2016, said renewal levy to be a rate not to exceed one and one-half (1.5) mills for each one dollar of valuation which amounts to fifteen (15) cents for each one hundred dollars of valuation.

NOW, THEREFORE, BE IT RESOLVED that there shall be submitted to the electors of said subdivision at the General Election on November 6, 2012 the question of renewal tax levy outside the ten (10) mill limitation in and for said subdivision in the amount of one and one-half (1.5) mills, for the purpose of providing additional funds for the City's portion of providing ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio; and that said additional one and one-half (1.5) mills shall be levied for five years 2012, 2013, 2014, 2015 and 2016.

BE IT FURTHER RESOLVED that the submission of said proposal, the notice of election, the form of ballot, the certificate of the levy as voted outside the ten (10) mill limitation, and the levying of such additional millage shall be in accordance with the provisions of Section 5705.19, 5705.191 and 5705.25 and other related sections of the OHIO REVISED CODE, in accordance with the statutes in such cases made and provided; and

BE IT FURTHER RESOLVED that the form of the ballot cast at such election shall be:

(A majority affirmative vote is necessary for passage)

"A renewal of a tax for the benefit of the City of North Canton, Stark County, Ohio, for the purpose of providing additional funds for the City's portion of providing ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio, at a rate not exceeding one and one half (1.5) mills for each one dollar of valuation which amounts to fifteen (15) cents for each one hundred dollars of valuation, for five (5) years, commencing with tax year 2012, first due in calendar year 2013."

An ordinance amending PART FIVE – GENERAL OFFENSES CODE of the Codified Ordinances of the City of North Canton to include Chapter 559 – Graffiti, requiring property owners to remove and restore any exterior surface where graffiti appears.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON,  
COUNTY OF STARK, STATE OF OHIO:

Section 1. That PART FIVE – GENERAL OFFENSES CODE of the Codified Ordinances of the City of North Canton, be, and the same is hereby amended to read as follows:

**“ CHAPTER 559 – GRAFFITI**

**DEFINITION:**

Graffiti: Means any inscription, design, word, figure or mark of any type drawn, marked, painted, tagged or written upon any building, bridge, fence, gate, rock, structure, tree, wall or other property visible to the public which defaces, damages or destroys any public or private, real or personal property.

**REQUIREMENTS:**

Graffiti Prohibition and Removal: All exterior parts of dwelling and commercial buildings and structures and property areas shall be free of graffiti. The owner(s) shall remove graffiti at the owner(s) cost from the aforementioned buildings, structures, parts, and property areas when the graffiti is visible from the street or other public or private property.

**PENALTY:**

Whoever violates any provision of this General Offense Code or any rule or regulation promulgated thereunder or fails to comply therewith or with any written notice or written order issued thereunder, is guilty of a misdemeanor of the first degree for each offense. Each day such violation occurs or continues shall constitute a separate offense.”
