Ordinance No. 25-13 - 2nd Reading - Finance & Property

An ordinance authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into an amended Canton-North Canton Sewer Agreement Supplement by and between the City of North Canton, Ohio, ("North Canton"), and the City of Canton, Ohio, ("Canton") for the Phosphorous/Total Nitrogen and Miscellaneous Improvements Project (MBR Procurement and construction) to the Canton Water Reclamation Facility, and declaring the same to be an emergency.

Mr. Snyder: Chairman Cerreta.

Mr. Kiesling: Actually, it's under you...

Mr. Snyder: Oh. That should be water. Alright, I'll report on it.

Mrs. Kiesling: They were backwards.

Mr. Snyder: Is that what it was?

Mrs. Kiesling: No, it's not you. It's fine.

Mr. Snyder: Actually, you knew last week we had Mr. Mills from the City of Canton along with Bill Bartos. He trained up here and then he went down there and showed them how to do it. So he came back to let us know how well he was trained. But this agreement originally started out to be about 71/2% and it's now down I think, to 21/2%. Correct?

Mr. Benekos: Correct.

Mr. Snyder: And this is an agreement that we have with the City of Canton. It's our share of the amount of waste going to the treatment plant. It's about an 85 million dollar project. These costs will not ...inaudible... to the City until the first money begins to be, until the debt service begins. However, we're going to pass this. We'd like to pass this. We had one reading we passed, this is the second reading. I'd like to pass it. I realize they wanted an emergency, but we have other matters that we're dealing with so we would like to have the Mayor speak to the Administration in Canton regarding those. So we will consider this again, if the Mayor is successful by next Monday, for the third reading leaving an emergency in there which won't come effective, and that's, if the Council concurs, we'll leave it at that.

Mr. Foltz: So we'll just pass the second reading?
