Ordinance No. 80 – 2014

An ordinance amending Chapter 155 Personnel Regulations of Part One-Administrative Code of the Codified Ordinances of the City of North Canton, as amended, specifically Section 4. LONGEVITY, to reduce Longevity from an annual payment of \$70.00 for each year of full-time City employment to a one-time payment of \$35.00 for each year of full-time City employment, and discontinuing Longevity payments as of December 31, 2014.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. That Chapter 155 Personnel Regulations of Part One-Administrative Code of the Codified Ordinances of the City of North Canton, specifically Section 4. LONGEVITY, to reduce Longevity from an annual payment of \$70.00 for each year of full-time City employment to a one-time payment of \$35.00 for each year of full-time City employment, and discontinuing Longevity payments as of December 31, 2014, be, and the same are hereby amended to read as follows:

Section 2. **LONGEVITY PAY PLAN**

1. That permanent, full-time City employees, who have completed at least five (5) years of continuous service with the City, shall receive a one-time longevity payment at the rate of thirty-five (\$35.00) dollars per year of full-time, continuous City employment. The longevity time period shall be determined from December 1<sup>st</sup> to November 30<sup>th</sup> of each year. Payment shall be made during the first half of the month of December 2014.

2. City employees hired after August 1, 2006, are not eligible for Longevity payments.

3. Longevity pay shall be discontinued as of December 31, 2014.

Section 3. That Section 4, Longevity Pay Plan of Ordinance No. 92-12, and any and all legislation inconsistent herewith, be, and is hereby repealed.

Section 4. That if a provision of this ordinance is or becomes illegal, invalid, or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.

Section 5. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.

Ordinance No. 81 - 2014

An ordinance authorizing the vacation of a portion of McKinley Avenue SE, from the south line of East Maple Street southerly to Lot No. 6989, located within the corporate limits of the City of North Canton.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

- Section 1. That said portions of McKinley Avenue SE, from the south line of East Maple Street southerly to Lot No. 6989, and located within the corporate limits of the City of North Canton, be, and the same are hereby vacated.
- Section 2. That the vacation plat is on file in the Engineer's Office, who shall record the vacation at the Stark County Recorder's Office upon the effective date of this ordinance.
- Section 3. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.

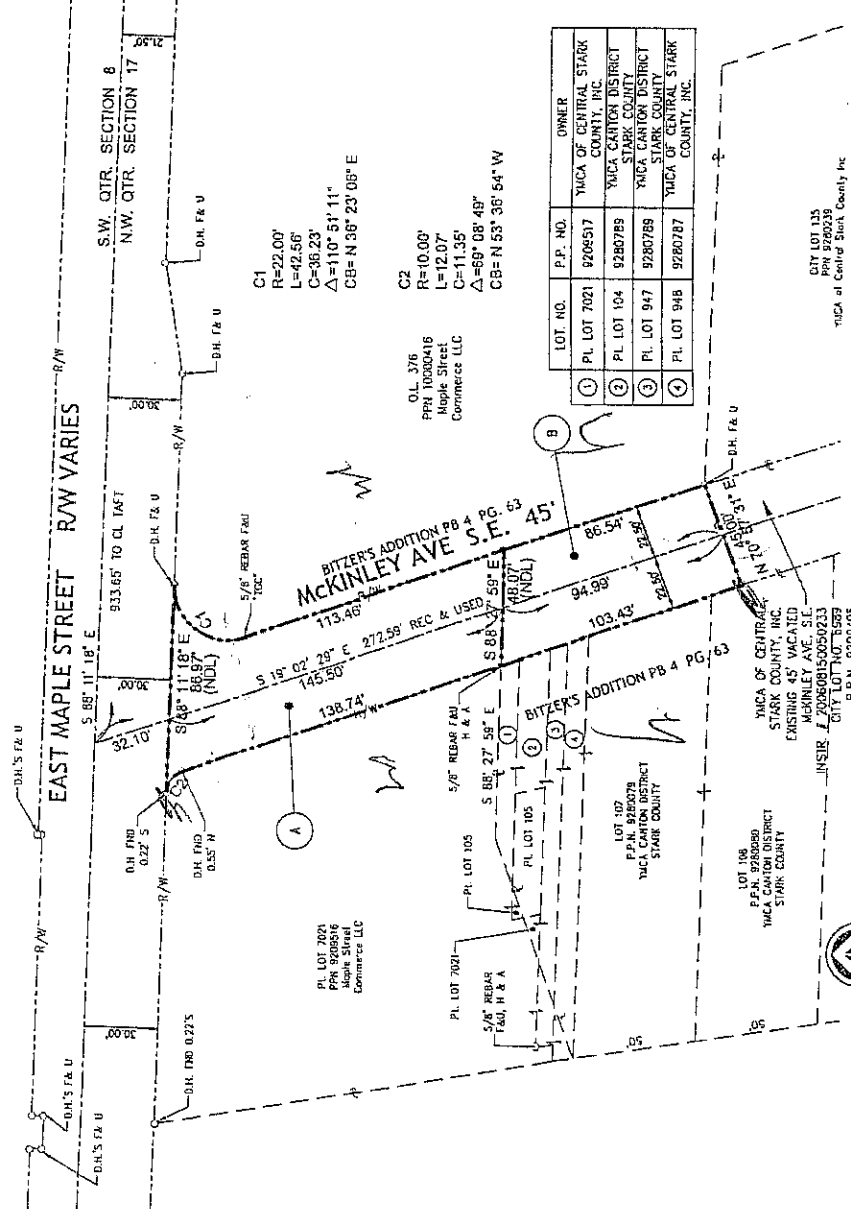

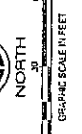

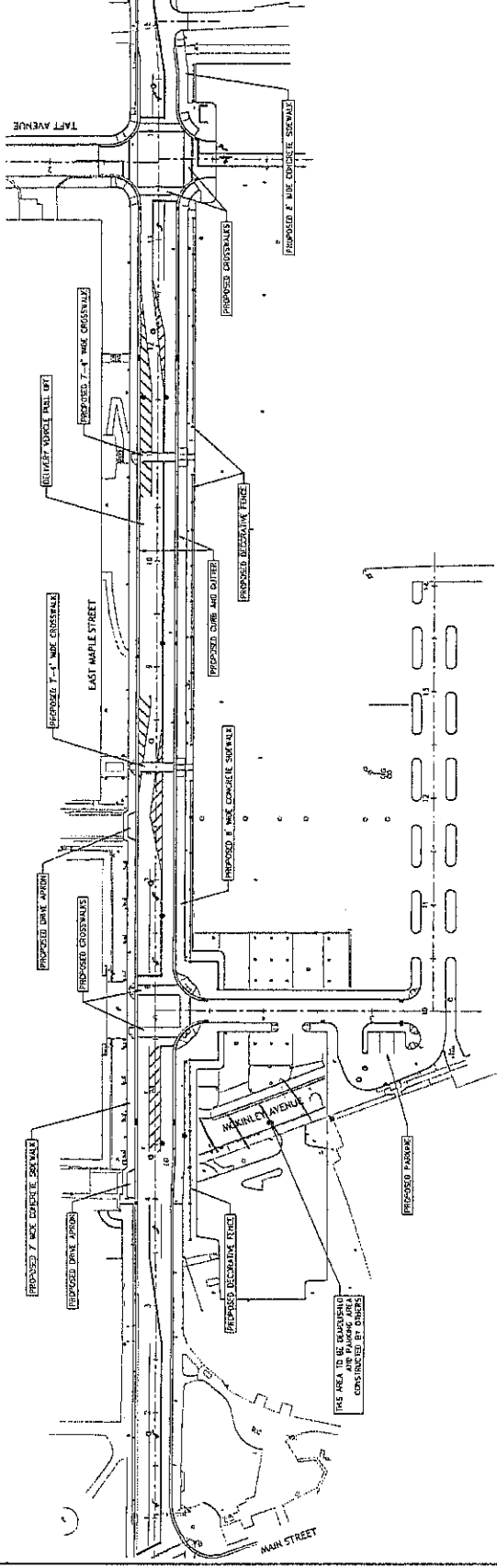
