Ordinance, Rules, and Claims Committee

An ordinance amending CHAPTER 553 – WEEDS, TREES, AND GRASS, specifically Section 553.01 SHRUBBERY AND OTHER OBSTRUCTIONS PROHIBITED ON LAWN STRIPS, of the Codified Ordinances of the City of North Canton to include the prohibition of placing lawn clippings and other lawn debris on public streets, sidewalks, curbs, or gutters, and declaring the same to be an emergency.

ORDINANCE NO. 60 – 2014 WAS PASSED BY A ROLL CALL VOTE OF 6 YES.


COUNCIL PRESIDENT PETERS: Thank you, may I have a motion to adjourn.


COUNCILWOMAN WERREN: So moved.
