An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into an Agreement for the purchase of one (1) portable road patch machine for use by the Street Department from a vendor or, in the alternative, pursuant to the Ohio Cooperative Purchase Act, and declaring the same to be an emergency.

Mr. Peters: Chairman Snyder.

Mr. Snyder: Thank you, Mr. President. After we talked about that and approved it, I spoke to Superintendent Davis. He seemed to have been able to negotiate an additional – quite a savings on the piece of equipment itself. And the savings was great enough that he was able to buy \$12,000 worth of supplies that go into the machine. So through his efforts – if you see the Superintendent, thank him. He did bring it in under budget including all the supplies. And he's anxiously awaiting approval of the Board. He says as soon as he gets that he'll be out on the street with it. And as you recall, he told you the holes that he fixed are permanent repairs. You're not going to have to go back and look at them again. So the overall savings will be very significant to the City. And the cost of the machine is a little over \$50,000 as it was originally at 69 (69,000). So you did a great job on that and we appreciate that from the Administration.

Mr. Griffith: I had chance to talk to a colleague of mine who is in the paving business, not in our area. And I asked him about these machines in particular and he could not say enough good things about them. He said it's brilliant, it's a smart move. They're working with a lot of smaller towns who will use this as a more permanent fix, because they don't have the money that we do or even less than we do. So I think it was a very good move and we're going to bear fruit for it long term. So

Mrs. Werren: Dave, is this the same machine, and I think it is, where they shared within the three townships. Remember we had talked about that when we were doing the budget. I think it was Tallmadge, and Kent, and Stow.

Mayor Held: I don't know if it's the same machine. But I do know that what the City of Cleveland they - they're renting them. They have like three of them that

Mr. Grimes: Theirs is different.

Mrs. Werren: Well that's what I wondered.

Mayor Held: Theirs is a bigger one, right?

Mrs. Werren: I was at a Walsh Luncheon on Friday afternoon, their business students had this lunch and there were over 350 people there. And it was just again another reminder of how important Walsh is to this community and the people. It wasn't – there – it wasn't just students, I mean there were people from all over the community who I saw and recognized and talked with and to have that asset here and be able to use that community room and the parking, it's just tremendous. And we just need to keep remembering how important that is and the Washington Square. And when people say like, oh we don't have things that people visit, they do. I know most certainly that people even went over afterwards and were – they were going to have a drink at Winking Lizard, they were going to go to Walgreen's, stop up and maybe pick their groceries up. And we just have to keep remembering that all those things that we keep doing they do bring people in, and it's a big deal. And I'm real excited to see this with the North Canton tennis courts and our partnership with the schools. I think those kind of things are so important. And I hope that Plain Local, since my kids go to Plain Local and we do not have tennis courts, and have not had them repave forever, see something like this and see that those partnerships between the Trustees and the schools can work and what a good program it's creating for your North Canton Schools. So that's great. I think that's it for now.

Mr. Peters: Member Snyder:

Mr. Snyder: Thank you. A couple of things: number one, I received an email today from Sarah Buehl at Stark Parks regarding the grants down there at the Zimber. As you know, we've been working on that for a little over a year. I spoke at length today to Representative Schuring. We've tentatively set a meeting for the 15th of May to which we'll have the Director Hoopingarner from the Muskingham, as they're viable partner. They're putting up our share of the grant. He'll be there as well and bring us up to speed on the Army Corp's study of the Zimber and what they're going to be doing. So he'll be there also. And members of the Emergency Management Team of the State of Ohio will be there. The grant has passed through all hurdles with exception of the last one that is now at the Historical Preservation Office. Once they sign off, hopefully by the end of April, it will go into the government for the required okay to FEMA (Federal Emergency Management Agency) to go ahead and begin the distribution of the money. And I think we have – as I told you thirteen homes. We applied for an additional thirteen and were unsuccessful to reach that grant. And we'll see what happens. So hopefully we'll be able to take those and get them done. And we've been fortunate so far, we haven't had the rains or the snow melts in that area. And there is some remedial measuring that goes on in the creek and all the City, it's like a snow alert. They all drive down there and start measuring the water as it rains. But hopefully we'll have this thing ready to go and in the hands of the residents down there by the first of June. So that is on Thursday evening at 6:00 at the Civic Center. Next Tuesday at the Civic Center will be a meeting on the actual trail, which might be encompassed. That's one of the ideas of using some of that land coming through our park and up. That's – there's three proposals and they're going to be at the Civic Center, Stark Parks, next Tuesday, I think at 6:00 to find out how they're going to actually bring that through the City of North Canton to connect eventually here to the "Y". the property lines, they would be a little difficult, they'd by right on their front porch, so - although Glenwood does need sidewalks for safety. It's not maybe the answer to that, but so I would encourage anybody that knows anybody on Glenwood, and I will alert my constituency there to come to that meeting for that purpose. And lastly I spoke to - last time I believe I had the privilege of being with Director Grimes and Engineer Benekos and we were on a conference call to a fellow in California who has the ability, he claims, to support our efforts to do 5 to 9 million dollars' worth of street paving. With your permission, I'm going to ask the Law Director to verify his credentials. He's not done this. He does a lot of bridges, a lot of other things, but not a lot of municipal road work. And that would be done with the monies that we raise from our existing street levy. He would leverage that into several million dollars. And so if I have your permission of the Council to go ahead and ask the Law Director to go ahead and verify it, we'll bring him in here in the next couple of weeks and have him talk to us and then we'll find out. But our roads are in terrible condition, as every municipality is, and we just don't - I don't see where we're going to come up with this money to rebuild a lot of these streets. And this would be set out with our five-year plan and we'd all know where our streets are going to be without any additional cost to the residents. I mean, it's costing them on the average of - they're all paying into that levy which generates a little over \$400,000 right now, and that will be up for renewal this fall. But we want to do that so that we can address that. That's economic development fundamentally without good roads and good streets. Once we fix those up, people fix their homes up

Mr. Foltz: Exactly.

Mr. Snyder: And it's a - you know if we let it alone, we start having deteriorating neighborhoods and that puts....

Mrs. Werren: Inaudible... said that, and they want to move.

Mr. Snyder: Yeah, they move, they just - or some of them they can't sell their home because there's a big pothole or the streets are crumbling in. You know when you see - we're the most envied government in the county for the condition of our streets and the way we maintain them. We're starting to slip there a little bit. Mrs. Werren: Okay.

REPORTS:

Mr. Peters: Law Director

Mr. Fox: Yes, sir. Gayle Bruce in our income Tax Department has started the counting for our collection on taxes in maybe a more meaningful way so you can see the result of what's happening in Mayor's Court. Each time, each day that she receives a payment for an account that we had to file a complaint in Mayor's Court to compel payment, she's just logging that in each day. And she went back and started that as of January 1st, and so far for our first three months this year we've averaged, just in collection of overdue income tax for the City, of \$8,000 each month. So that continues to bode well. We hope eventually once we get these taken care of, the backlog, that number won't be as substantial, but it is promising. We still have a number of those that have neglected to file, neglected to pay, and we'll stay after those. And it was not - it didn't appear overwhelming, I can't speak for the folks ...inaudible... income tax, but it was steady. There was just three, four, or five people just constantly there. As soon as they'd be

taken care of there would be a couple more. So the filings were very busy today and we certainly anticipate the same thing tomorrow.

Mr. Cerreta: You know, Gayle Bruce, she does a hell of a job. If you would see her, I mean those of you who don't take time to, make sure you take time to make a comment to her about that, because I know she really appreciates that what she does, and that whole group. You guys are doing a wonderful job with that. That's something we never had. So good stuff.

Mr. Peters: Finance Director Alger.

Mrs. Alger: I piggyback on that, Gayle does a great job. She's very - it's a serious job for her. I mean she takes it in accuracy, everything. But like Tim said, we have not been as - as much in lines as we had anticipated and we really think it will be tomorrow. But yeah bear with us we will have probably the lines. But if you want an extension, you have to do that in writing, and it needs to be postmarked by tomorrow. So I thought I'd just let you know. That's it.

Mr. Peters: Okay. Director Grimes.

Mr. Grimes: Our street sweeper has a major break. Even though they've had it ready to go the first time they took it out there was a major problem with it. We're going to get that fixed, obviously. We had the crews out today sweeping the sidewalks between Charlotte and Bachtel on Main Street and scrapping up what they could. They were out on foot with the machine that power washes the sidewalks. So we'll get what we can, but we'll get the street sweeper fixed. That's why it wasn't out there, and you haven't seen it. Nuisance officers already removed this month, 11 junk motor vehicles from different places and they got them out. So you know we're moving on that. We're picking the easy ones right at the beginning to get our process down and then we'll - but we're out there. So we'll be doing that. I'll get a media release out to everybody, but May 12th we'll start selling pool tickets here at City Hall, and we'll release that in the next day or two. The price is the same as it was last year, but we'll start selling them here May 12th. So thank you, sir.

Mr. Peters: Mr. Mayor

Mayor Held: Yes. first of off I appreciate Council passing this resolution for the Declaratory Judgment. Thank you for doing that. And hopefully one way or another we'll have to file a determination here in the next what 30 to 60 days, hopefully sooner. And also, the State of the City, I think that....

Mrs. Werren: Nice Job.

Mayor Held: Thank you. I appreciate you all coming. It's, you know when you go through that process as Dan and Mark had mentioned, and also all of our Council members about going through our budget and you know that really, doing the State of the City it just forces you to go through every aspect of the budget. Tried to simplify it as best that we could, but we see that we've got a lot of challenges this next year that we simply have to address because the inheritance tax really was kind of like the silent supporter of our budget for many years. I mean on average we would collect \$800,000 a year. It was never below \$400,000. That's a lot of money. And in addition to that, our local government funds, our high point was close to a million, and now we're down to below what, \$300,000? So it's had a significant impact. And not to sound, you know, negative or cynical because at the same time our income tax is going up, but the overall pie is smaller. And the Administrator, and our Finance Director, and Law Director, our Engineer, all the department heads, they've really done a very good job of keeping things cost effective. So I appreciate Council's support on that area. And we will start working early on next year's budget, because we're going to have to make some decisions as far as our revenue, what we're going to do for next year. And also, we did have a TAP (Talk About Potential) that was just the week before, and TAP is Talked about Potential. A lot of community leaders get together. We had Richard Jusseaume that addressed TAP. And Richard has had a lot of success at Walsh. You know, he's built a lot of buildings, the institution has grown. And the purpose of that was to meet and talk about how we can improve the relationship between the City and Walsh, and so Richard has some ideas how we can do that. We'd like to improve communication. The one area that he spoke very highly of was Jim Benekos, our City Engineer. Because when you look at what Walsh is doing in their growth over there, they're going to be widening Market, but at the same time they've wanted to tie in new ingress and egress along Maple there. So that's what Jim's done is tied in the different grants, you know, like we talked about at the State of the City. I'm not quite sure how you do it, but it really doesn't - we don't need to understand it, we just benefit from it. So he's working on tying in different grants so



An ordinance amending CHAPTER 935 – WATER LINES AND HYDRANTS, specifically Section 935.02(b)(4) Water Tap-In Fees, of the Codified Ordinances of the City of North Canton, to establish fees and usage policies.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

Section 1. That CHAPTER 935 – WATER LINES AND HYDRANTS, specifically Section 935.02(b)(4) Water Tap-In Fees, of the Codified Ordinances of the City of North Canton, be, and the same is hereby amended to read as follows:

935.02 CONNECTION CHARGE OTHER THAN BY ASSESSMENT.

(a) Fee Where Connection Cost is not Paid by Assessment.

(1) Where a connection is made into a waterline, the front foot cost of \$25.00 per foot shall be paid into the City Treasury before the connection may be permitted.

(2) Upon authority of the Director of Finance and the Director of Administration, on a case-by-case basis, a payment plan or payment plans may be established for the connection and tap-in fees for residential single owner-occupied premises connecting to preexisting waterlines of the City's water system, located within the City, and with said payment plans not to exceed one year.

(b) Water Tap-In Fees.

(1) Water tap-in fees for City water Customers, are hereby established as follows:

(4) The contractor shall be responsible for the cost of all material and labor and other costs associated with water service from the water main to the meter. The City shall tap the water main.

Section 2. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.

Section 3. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.

RE: New Levy Resolutions


I am requesting that Council place on the agenda for the next Council of the Whole the adoption of two new resolutions for the storm sewer levy and street improvement levy. The previous resolutions (61-09 and 62-09) had the levy commencing in the tax year 2010, however the current levies don't expire until the tax year 2015. Therefore, the renewal levy should commence in the tax year 2015 (and collected in 2016).

Both the 1.0 mill Street Improvement Levy and the 1.0 mill Storm Sewer Levy are five year levies. We receive approximately \$354,695 annually from each levy.

To determine what amount of funds a renewal levy will generate is to first request a certification from the County Auditor. Council will be required to adopt legislation requesting a certification from the County Auditor as to the amount of funds a renewal (or a renewal and increase, etc.) will generate.

There should be an ordinance for each request. Once we receive the certification from the County, Council can then make a more informed decision regarding these levies. Council can request a certification as to what a new 1.0 mill levy might generate, or a 1.50 mill levy might generate, or a 2.0 mill levy might generate, etc... I am requesting that Council pass the first piece of legislation as an emergency in order to make sure we meet the Board of Elections deadline of August 6, 2014.
