ORDINANCE 49 - 2021

An ordinance authorizing the appropriation of funds of the City of North Canton to be appropriated for current expenses related to the Dogwood Park Improvement Project during the fiscal year ending December 31, 2021.

WHEREAS, the City requires \$500,000.00 for the completion of the Dogwood Park improvement project; and

WHEREAS, such funds shall be reallocated within the capital improvement fund from Paving, Curbs, & Gutters projects to Parks projects.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

Section 1. That to provide for the current expenses and other expenditures of the City of North Canton, during the fiscal year ending December 31, 2021, the following funds, be, and are hereby, set aside and appropriated as follows:

330.546	Paving, Curbs, & Gutters	Other Operating	\$(500,000.00)
330.309	Parks Dept.	Other Operating	\$ 500,000.00
TOTAL SUPPLEMENTAL APPROPRIATIONS			\$0.00

Section 2. That the Director of Finance, be, and is hereby authorized to issue warrants from appropriations established herein for the payment of vouchers duly approved by the proper departmental authority.

Section 3. That if a provision of this ordinance is or becomes illegal, invalid, or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.

Section 4. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.
