**1. Call to Order**

Chairman Lane called the meeting to order at 7:30 AM.

**2. Roll Call**

Members Lane and Stephens responded to roll call.

**3. New Business**

*a. Certify Eligible List for Fire/EMS 1 Full-Time Entry*

Secretary Young presented the results of the June 7, 2022, Fire/EMS 1 Full-Time entry exam. There were no protests filed and all nine applicants passed the exam. The resulting eligible list was certified with 2 in favor and 0 opposed.

*b. Certify Eligible List for Dispatch 1 Full-Time Entry*

Secretary Young presented the results of the June 10, 2022, Dispatch 1 Full-Time entry exam. There were no protests filed and the sole applicant passed the exam. The resulting eligible list was certified with 2 in favor and 0 opposed.

*c. Authorization of new Police 2 (Sergeant) exam pursuant to Rule 5.05*

Secretary Young requested the Commission not certify an eligible list for the Police 2, Sergeant, promotional exam held on June 28, 2022. Only one applicant passed the exam and pursuant to Rule 5.05 the Commission may authorize a new exam, open to a larger pool of applicants, if less than 3 applicants pass. The new exam would be held on August 29, 2022 at 1:00 PM. The proposed reference materials for the new exam would remain the same as the previous exam. The proposed new Police 2 exam was authorized with 2 in favor and 0 opposed and no eligible list was certified.

With no further business the meeting was adjourned at approximately 7:34 AM.
