24 1127, Establishment of Districts and Map,  
25 specifically Section 1127.01, Establishment of

1           Districts, of the codified ordinances of the City of  
2           North Canton in order to remove the chart of  
3           districts contained therein.

4           MR. STROIA: Chairman Revoldt, would you like  
5           to summarize.

6           MR. REVOLDT: Just to reiterate or refresh  
7           memories, this is an effort to make a housekeeping or  
8           technical correction so we have the permitted uses  
9           listed in one location as opposed to two, so down the  
10          road if we change one, we err and don't complete the  
11          other, we don't have an inconsistency. We have it in  
12          one location. One word. Any questions or comments?

13          MR. STROIA: No. Then we'll open the floor  
14          to the public.

15          Okay. At this time anyone wishing to speak  
16          in favor of the ordinance.

17          MRS. WERREN: Come on, Brad.

18          MR. DAVIS: Not my cup of tea.

19          MR. STROIA: Okay. Seeing none at this time,  
20          anyone wishing to speak against the ordinance.
