To assist you in placement of a temporary sign, we have summarized the requirements.

1. Each business is permitted to place one (1) temporary sign for a maximum of thirty (30) consecutive days, one time per calendar year.
2. Maximum area in a business zone is thirty two (32) square feet.
3. Maximum height is eight (8) feet in General Business zoning and six (6) feet in Office Building zoning.
4. Temporary signs must be at least ten (10) feet from the street right of way.
5. The temporary sign may be a banner or a free-standing sign, however, signs on wheels are illegal.
6. A temporary sign permit is required **before** display of the sign.
