ORDINANCE 35 - 2020

An ordinance authorizing the appropriation of funds received under Section 5001 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) for current expenses during the fiscal year ending December 31, 2020, creating related funds, and declaring the same to be an emergency.

WHEREAS, the City anticipates receiving \$352,200.00 in coronavirus relief funds as a result of the CARES Act and Ohio Senate Bill 310 of the 133rd General Assembly (S.B. 310); and

WHEREAS, the City must create appropriate accounting funds to ensure proper accounting and expenditure practices of the anticipated coronavirus relief funds; and

WHEREAS, an emergency exists in that the City received only seven days' notice to enact appropriate legislation and register with the State of Ohio Office of Budget and Management to receive coronavirus relief funds.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

Section 1. That the Director of Finance is hereby authorized to establish the CARES Act Coronavirus/COVID-19 Relief Fund, number 219, in accordance with the provisions of Section 5705 of the Ohio Revised Code, for the purpose of enabling the required accounting of receipts and expenditures applicable to unanticipated costs related to the outbreak of COVID-19, the imposition of related health restrictions, and Ohio Governor Mike DeWine's declaration of a state of emergency, Executive Order 2020-01D.

Section 2. That to provide for the current expenses and other expenditures of the City of North Canton, during the fiscal year ending December 31, 2020, the following funds, be, and are hereby set aside and appropriated as follows:

Section 3. That if a provision of this ordinance is or becomes illegal, invalid, or unenforceable, it shall not affect the validity or enforceability of any other provision of this ordinance.

Section 4. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and peace of the City of North Canton; and further necessary to meet the registration deadline of June 15, 2020, set by the State of Ohio, for the City to register to receive coronavirus relief funds under the CARES Act; wherefore, provided it receives the affirmative vote of six or more members of Council elected thereto, this ordinance shall take effect and be in full force upon its adoption by Council, together with the Mayor's approval. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
