RESOLUTION 10 - 2021

A resolution for the submission of the question of the renewal and increase of a tax levy for the purpose of providing additional funds for the City's portion of ambulance service, emergency medical service, or both, in the City of North Canton, Stark County, Ohio.

WHEREAS, the City of North Canton upon due investigation and consideration has determined that the amount of taxes which may be raised within the ten-mill limitation in and for the City of North Canton, Stark County, Ohio, for the next five years, pursuant to the provisions of Section 5705.02 of the Ohio Revised Code, will be insufficient to provide adequate funding for the purpose of providing ambulance service, emergency medical service, or both, in the City of North Canton; and

WHEREAS, by reason of the facts above set forth, Council has determined it should, and hereby declares it shall, submit to the electors of the City of North Canton for the November 2, 2021 general election, the question of renewing and increasing the existing tax levy of one and five-tenths (1.5) mills outside the ten-mill limitation for the purpose of providing ambulance service, emergency medical service, or both, in the City of North Canton, Stark County, Ohio, for a period not to exceed five years, being calendar years 2022, 2023, 2024, 2025 and 2026, and that said renewal and increase levy shall be at rate not to exceed three and three-tenths (3.3) mills for each one dollar of valuation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:

Section 1. That there shall be submitted to the electors of the City of North Canton, Stark County, Ohio, for the November 2, 2021 general election, the question of a renewal and increase of the existing tax levy outside the 10-mill limitation in and for said subdivision in the amount of three and three-tenths (3.3) mills, for the purpose of providing additional funds for the City's portion of providing ambulance service, emergency medical service, or both, in the City of North Canton, and that said additional three and three-tenths (3.3) mills shall be levied for five years, being calendar years 2022, 2023, 2024, 2025 and 2026.

Section 2. That the form of the ballot cast at such election shall be:

(A majority affirmative vote is necessary for passage.)

A renewal of one and one-half (1.5) mills and an increase of one and four-fifths (1.8) mills to constitute a tax for the benefit of the City of North Canton, Stark County, Ohio, for the purpose of providing additional funds for the City's portion of providing ambulance service, emergency medical service or both, in the City of North Canton, Stark County, Ohio, at a rate not exceeding three and three-tenths (3.3) mills for each one dollar of valuation which amounts to 33 cents for each one hundred dollars of valuation, for five years, commencing with tax year 2022, first due in calendar year 2023.

Section 3. That the Clerk of Council, be, and is hereby, directed and authorized to proceed forthwith with the certification hereof to the Board of Elections of Stark County, Ohio, pursuant to the provisions of Sections 5705.19, 5705.191 and 5705.25, and other relevant sections of the Ohio Revised Code, and to proceed with all things necessary to be done in order to accomplish the purpose of this resolution.

Section 4. That if a provision of this resolution is or becomes illegal, invalid, or unenforceable, it shall not affect the validity or enforceability of any other provision of this ordinance.

Section 5. That this resolution shall take effect and be in full force from and after the earliest period allowed by law.
